S 6. JP gave examples of where presentations had been made such as RCP regarding the review of 'Patients as Parents' and the DoH.

8.i. Links with LSCB. There was a discussion on accountability and purpose and the tension between provision of peer support and work with LSCB. Issues include how to link with the health representative on the LSCB to escalate up, receive briefing on what the board is doing, where and how we should have input and exchange information and advice in a two way process. The health link on LSCB is Sally Jones from Greenwich PCT for Trish Morris Thompson. Briony Ladbury Designated for Croydon PCT is now seconded two days a week to take forward safeguarding children for NHS London.

Action: SL to invite BL to the next meeting Jan. 9th 2008.

8.ii Links with London MH Chief Executives group. This will be through Andrew Turnbull through CSIP e.g. the Plan for London.

8.iii National network for named safeguarding children professionals in mental health Trusts. A worker has been appointed and has requested volunteers. JP is a member.

 SS CSIP presented the paper followed by discussion. Action: SS will redraft and shorten to identify key inconsistencies and gaps in information across Trusts and between information received from board leads and named professionals. The recommendations should ask the chief executive group for London mental health Trusts to:
- a) Receive and discuss the report
 - b) Recognise that arrangements are inadequate in some Trusts
 - c) Mandate the London mental health network to develop minimum standards for Trust infrastructures including staffing, roles and JDs policies, training, audits etc and report back to the chief executive group.

- 8 **London serious case review report.**
 CC was not available to present this but the presentation was tabled.
